I. PURPOSE

This memorandum documents the contents of a screenshot supplied for publication concerning a Minnesota child-support account involving Justin Casequin. The screenshot should be characterized as a **supplied Minnesota Child Support Online account screenshot**. It should not be characterized as a publicly accessible court judgment or public court docket unless a corresponding public court record is separately obtained and verified.

II. INFORMATION SHOWN IN THE SOURCE DOCUMENT

The screenshot identifies **Justin Casequin** as the obligor associated with the account and displays the following figures:

Record item	Amount shown
Current monthly support obligation	\$2,815.00
Current support balance shown	\$2,815.00
NPA arrears shown	\$119,728.21
Total amount owed on the case	\$122,543.21

The screenshot states: "The total amount the obligor owes on this case is \$122,543.21."

III. RECOMMENDED PUBLICATION LANGUAGE

Minnesota Child Support Account Record. A Minnesota Child Support Online account screenshot supplied for review identifies Justin Casequin as the obligor and shows a current monthly support obligation of **\$2,815.00**, **\$119,728.21 in NPA arrears**, and a **total amount owed on the case of \$122,543.21** at the time reflected by the screenshot.

This figure should be reported exactly as shown in the supplied account record and kept separate from commercial judgments and civil litigation discussed elsewhere. Because account balances can change through payments, adjustments, modifications, enforcement activity, or satisfaction, the website should not represent that \$122,543.21 remains the current balance today unless confirmed by a more recent official record.

IV. IMPORTANT LEGAL AND EDITORIAL DISTINCTIONS

The website should avoid stating that the screenshot is a public court judgment, that the amount is necessarily the current balance today, or that the record establishes criminal conduct. A precise formulation is: **“Support balance shown: \$122,543.21.”**

The support-account figure should not be combined with unrelated commercial judgments into a single judgment total. The family-support account record, civil judgments, and allegations in pending litigation are separate categories and should remain separately labeled.

V. PRIVACY REDACTIONS

Before public display, redact the child-support case/account number and unrelated third-party identifying information. Do not publish addresses, phone numbers, email addresses, Social Security information, birth dates, child information, or other unnecessary private identifiers.

The evidentiary portions that may remain visible for source context include the obligor name **Justin Casequin**, the \$2,815.00 monthly support figure, the \$119,728.21 NPA arrears figure, the \$122,543.21 total amount shown, and sufficient interface/domain context to identify Minnesota Child Support Online.

It is not represented as a current-balance certification or as a publicly docketed money judgment.
